- The Clubhouse consists of the Golf Shop, the Grill and the Winter Garden, with spectacular views of Georgian Bay, the course and the Niagara Escarpment.

*This agreement constitutes the entire agreement between the parties and is binding on each of the parties when each clause is read and the agreement is signed by the group's coordinator and returned to Lora Bay.

Section I: Cancellation

- 1) AN ENTIRE GROUP WILL NOT INCUR A PENALTY IF THEY CANCEL THIRTY (30) DAYS OR MORE PRIOR TO THE DATE(S) OF PLAY. A FULL REFUND OF YOUR "GOOD FAITH" DEPOSIT WILL BE ISSUED. CANCELLATIONS MUST BE MADE IN WRITING TO LORA BAY ON OR PRIOR TO THE (30) DAY DEADLINE.
- 2) AN ENTIRE GROUP CANCELLATION MADE LESS THAN THIRTY (30) DAYS AND MORE THAN SEVEN (7) DAYS PRIOR TO THE DATE(S) OF PLAY WILL BE CHARGED 50% OF THE TOTAL GREEN FEES.
- 3) AN ENTIRE GROUP CANCELLATION MADE INSIDE OF SEVEN (7) DAYS PRIOR TO THE DATE(S) OF PLAY WILL BE CHARGED 100% OF THE TOTAL GREEN FEES AND 50% OF CONFIRMED FOOD AND BEVERAGE.
- 4) LORA BAY RESERVES THE RIGHT, AND WILL GIVE NOTICE TO THE GROUP, TO ADJUST THE STARTING TIMES OF THE GROUP UP TO 30 DAYS PRIOR TO THE DATE(S) OF PLAY.
- 5) IN THE EVENT THAT SEVERE WEATHER CONDITIONS FORCE THE CLOSURE OF THE GOLF COURSE, THE DATE(S) OF PLAY WILL BE CANCELLED AND A FULL REFUND OF THE "GOOD FAITH" DEPOSIT WILL BE ISSUED. IN THE EVENT THAT THE CLOSURE OF THE GOLF COURSE OCCURS DURING THE ROUND OF GOLF A REFUND WILL BE ISSUED BUT IT WILL BE PRO-RATED BASED ON THE NUMBER OF HOLES THAT HAVE BEEN COMPLETED.

Section II: Attrition

- 6) THE NUMBER OF PLAYERS CONTRACTED TO PLAY WILL BE CONSIDERED FINAL SEVEN (7) DAYS PRIOR TO THE DATE(S) OF PLAY. ANY REDUCTION IN THE NUMBER OF PLAYERS WILL RESULT IN THE GROUP BEING CHARGED THE AGREED GREEN FEE PER PLAYER FOR THOSE REDUCTIONS.

Section III: General

- 7) ANY INCREASE IN THE NUMBER OF PLAYERS MUST BE APPROVED BY LORA BAY 7 DAYS PRIOR TO THE DATE(S) OF PLAY.

8) ALL PLAYERS MUST COMPLY WITH THE CLUB DRESS CODE WHICH STATES THAT A SHIRT WITH A COLLAR MUST BE WORN AND DENIM IS NOT PERMITTED. SHORTS MUST BE AT LEAST MID-THIGH IN LENGTH AND APPROPRIATE GOLF FOOTWEAR WITH SOFT SPIKES OR RUNNING SHOES. LORA BAY RECOMMENDS THAT ANY GROUP UTILIZING A SHOTGUN START ARRIVE AT LEAST 1 HOUR PRIOR TO THE SCHEDULED START TIME. PLAYER NAMES AND GROUP PAIRINGS MUST BE MADE AVAILABLE TO LORA BAY AT LEAST 72 HOURS IN ADVANCE OF THE SCHEDULED STARTING TIME ON THE DATE(S) OF PLAY. REVISIONS WILL BE CONSIDERED/ACCOMMODATED AT THE DISCRETION OF THE CLUB.

9) THE GROUP WILL BE RESPONSIBLE FOR ANY LOST OR DAMAGED EQUIPMENT, INCLUDING GOLF CARTS, RENTAL CLUBS, CAUSED BY THE GROUPS PARTICIPANTS.

10) FOOD & BEVERAGE PRODUCTS CONSUMED OR MADE AVAILABLE MUST BE PURCHASED FROM LORA BAY. AS WELL ANY PROMOTIONAL ITEMS, MERCHANDISE, OR PRIZES BROUGHT ONTO THE PREMISES REQUIRES PRIOR APPROVAL FROM LORA BAY.

11) BOOKINGS ARE SECURE UPON RECEIPT OF A SIGNED COPY OF THE TERMS AND CONDITIONS; LORA BAY ALSO REQUIRES A 50% DEPOSIT WITH THE SIGNED AND DATED CONTRACT. THE DEPOSIT MAY BE PAID BY MONEY ORDER, CHEQUE OR CREDIT CARD.

12) FINAL PAYMENT IS REQUIRED ON OR PRIOR TO THE DATE(S) OF PLAY. ACCEPTED METHODS OF PAYMENT ARE CASH, CREDIT CARD, OR CHEQUE MADE PAYABLE TO THE RAVEN GOLF CLUB AT LORA BAY.
